These Drop-in Pan Kits are available in square and round shapes of various sizes to accommodate different outdoor fire pit dimensions.

- 1. Stainless Steel Drop-in Pan (Square, Rectangular, or Round)
- 2. Stainless Steel Fire Pit Ring
- 3. Fire Pit Connection Kit w/ Key Valve
- 4. Push-Button Igniter Kit

IMPORTANT

Be sure to use gas thread seal for ALL non-tapered connections. Be sure to tighten ALL connections securely.

The Drop-in Pan Assembly can be installed in various configurations, as determined by the installer. In some instances, the Drop-in pan is installed using hard pipe, and is supported by "filler" aggregate underneath the Drop-in pan. Some install the Drop-in pan in a "sandwiched" method or on top of a "step" as part of the fire pit structure.

American Fire Glass™ always recommends the components be installed by a licensed professional, and in accordance with Federal, State, and local regulations such as ANSI Z21.97-2012 and CSA 2.41-2012, latest editions.

Assembly Instructions:

'* Use Teflon tape or sealing compound on all pipe threads (only). Do not use on flare fittings.

STEP 1 - Install Fire Pit Ring plug into the top of the fire pit ring. Gas exit holes can be facing up or down. (FIGURE 1) Do not over tighten.

Tip! We recommend gas outlet holes up for propane. Gas outlet holes are acceptable up or down for natural gas.

STEP 2 - Screw fire pit ring onto the Drop-in Pan. (FIGURE 2) Do not over tighten.

STEP 3 - Insert the Spark Igniter Probe assembly and mounting plate into the Drop-in Pan, and secure with the provided screw and nut. (FIGURE 3)

Tip! For best results, fill pan with burner media before ignition.

STEP 4 - **For LP installation only - Attach the Air Mixer Assembly to the $\frac{1}{2}$ male threads on the bottom of the pan. Be sure the stamped arrow on the Propane Air Mixer is pointing toward the fire pit ring. The arrow indicates the direction of gas flow. (FIGURE 4)

NOTE: For Natural Gas installations, the Propane Air Mixer is not utilized. The Natural Gas configuration does not use a propane regulator.

STEP 5 - Attach the Gas Hose from the exit side of the Key Valve to the bottom of the Propane Air Mixer. The Gas Hose uses a 3/8" flared male to ½" Female adapter (included) for connecting to the Drop-in Pan. **(FIGURE 5)**

STEP 6 - Attach the Igniter Spark Probe Wire and the Igniter Ground Wire to the back of the Push Button Assy. Either wire can be placed on either pin. Connect the eyelet end of the ground wire to a clean metal ground surface.

NOTE: The location and mounting of the key valve and push button assembly is to be determined by the installer.

'* See Figure 6 for optional Ignitor/Key Valve mounting plate.

STEP 7 - Unscrew the Push Button rubber cap and be sure that the AA battery is installed with the "-" side facing the rubber button. Re-attach the Push Button rubber cap by gently turning it clockwise until snug.

STEP 8 - Install Fire glass on top of the Drop-in Pan/Fire Pit Ring. A fire glass depth of 2" is recommended.

NOTE: To avoid excessive heat to the fire pit ring/Drop-in pan, do not Light without fire glass installed for more than 30 seconds. When fire glass is installed the flame burns above the fire glass, not directly on the stainless-steel components.
